IMPORTANT: Instructions to Confirm Your Admission under NRI Quota

1. **Note:** NRI seats (maximum 5 %) are a subset of the **Institutional (IL) Quota**. Should any NRI candidates fail to **report as per the schedule**, such seats shall revert back to the **Institutional Quota (IL)** and be offered to eligible candidates **based on merit** under that quota, in accordance with the rules specified in admission brochure 2025 of MHCET.
2. If a candidate fails to **report for admission** or does not **complete the document verification and fee payment** within the stipulated schedule of admission round, the allotted seat shall be deemed **forfeited** without any further notice. Such a seat

will be declared **vacant** and shall be offered to the **next eligible candidate** from the waiting list as per merit. The defaulting candidate will **lose any claim** and the seat will be offered to next eligible candidate as per merit from the waiting list.

3. Students are advised to accept and freeze their seats at the earliest to secure their desired B.Tech program, as seats are limited.
4. Confirm your acceptance of the allotted seat by paying the first-year fees through the Foreign Candidate Registration (FCR) Portal of DTE in online mode.
5. Your admission claim will be valid only after PCCOE confirms your payment through the FCR portal.
6. Report to the institute in person with all original documents (as per DTE guidelines) on or before the deadline.
7. Admission will be finalized only after successful verification of all required documents.
8. Failure to pay the fees and report within the specified deadline will result in automatic cancellation of your seat, which will then be offered to the next eligible candidate as per merit.
9. Make fee payments strictly through the official DTE FCR portal; PCCOE does not authorize any third-party payment methods or agents.
10. Any discrepancy in document submission or non-fulfillment of eligibility criteria as per DTE/AICTE norms will lead to cancellation of admission.
11. All admissions are provisional and subject to final approval by DTE and PCCOE authorities.
12. The admission schedule is subject to change due to unavoidable circumstances; candidates are advised to **regularly visit the PCCOE website** (www.pccoepune.com) for the latest updates.
13. Vacancies if any after Round 1 and 2 may be filled by conducting additional round(s) as per the guidelines of DTE/MHCET Cell.
